



Campsite terms and conditions

- For the entrance to the Camping is mandatory the authorization of the Management and the relative registration of law, the issue of the authorization implies the full acceptance of this Regulation.
- The rates of stay at the Camping, displayed at the reception, go from arrival until 1p.m. the next day, unless otherwise agreed.
- The arrival at the Camping is allowed after 3p.m., unless otherwise agreed.
- From 11p.m. to 7a.m. and from 1p.m. to 3p.m. is prescribed the moderation of noise. At these times, access to any motor vehicle will also be prohibited.
- The occupancy of the tent or caravan is subject to the authorization of the Management and must take place outside the hours of silence established by the Management itself.
- The parking of vehicles is allowed in the spaces indicated by the Direction, which may, according to the needs, invite to move in another space.
- Guests must take care of their own property. The Management is not responsible for any theft or damage except for the objects entrusted to it and accepted in delivery with receipt.
- The speed of vehicles within the tourist complex shall not exceed 5 km/h.
- It is mandatory to respect the vegetation, hygiene and cleanliness of the complex. It is forbidden to wash dishes and linen outside the appropriate places and specially indicated. It is forbidden to dig ditches and holes in the ground, to light fires and to use the camping equipment in an inappropriate way. Children, in the use of various equipment and toilets, must always be accompanied.
- The owners of animals are obliged to communicate it to the Management who has the right to welcome them or not.
- The electrical connection to the appropriate sockets, with the permission of the Management, is allowed only for lighting and refrigerator. The connecting cables must be equipped with the third "ground" wire and comply with the safety standards "CEI" and "UNI". The use of any electric heater is strictly prohibited.
- It is strictly forbidden the placement of gazebos in pitch, unless otherwise agreed.
- In the opinion of the Management, failure to comply with these rules and behaviour that damages the harmony and spirit of the settlement, may lead to the removal from the camp, as an unwanted guest.
- Guests must comply with any changes and additions to these regulations given by the Management and posted at the entrance of the Camping, as well as those given by the Veneto Region.
- The owners of animals must take care of and clean them so that they do not cause any disturbance or damage.

- Parents or others, are asked to check and eventually curb the excesses of the children.
- The Management reserves the right to change the arrangement of caravans, tents or machines at any time.
- The Management declines all responsibility in case of damage suffered due to natural disasters or vandalism.
- Parking is allowed at your own caravan or tent of a single car. Additional vehicles should be parked in designated outdoor parking areas.
- Visits within the area reserved for guests are tolerated only with the permission of the Management, after the delivery of a personal ID and the payment of the daily rate provided that the number of people and frequency are limited.
- The assembly of any model of winter pre-entrance, regardless of the size or the material used, is strictly subject to the approval of the Management which, if not, reserves the right to have it dismantled at any time.
- In order to avoid unnecessary disputes, the Management stresses that any different rules, applied in other campsites, have no value in this.
